This cause came to be heard on the 27 day of
August, 1988, upon the final account, petition to
settle and allow account and for authority to distribute estate by
Verla B. Flick, as personal representative of the estate of William
Ray Flick, deceased, which account and petition are in the words
and figures following, to-wit:

And it appearing that no objections were filed thereto and the
Court being fully advised in the premises now finds that
the records of the filing of said account and petition and
of the hearing on the same were given to all persons interested in
said estate, and the same are now properly before the court for
final action thereon.

2. That William Ray Flick, died testate, a resident of the
County of Orange, State of Indiana, on the 23rd day of June, 1987,
and his Last Will and Testament was duly admitted to probate before
this Court on the 2nd day of July, 1987, and this Court appointed
said Verla B. Flick as personal representative of the Last Will and
Testament of the decedent, and said personal representative was
issued Letters of Testamentary on the 2nd day of July, 1987, to her
and since that date she has continued to serve in such capacity.

3. That the matters and things stated in said account and
petition are true, and that said personal representative has
accounted for all the assets in said estate coming into her hands.

4. More than five (5) months have elapsed since the date of
first published notice to legatees, devisees and creditors of said
decedent; all claims filed against said estate have been paid and
discharged; neither said decedent nor his personal representative
were employers of labor within the meaning of that term as used in
the Indiana Employment Security Act; all estate taxes, inheritance

5. That Verla B. Flick, is the sole and only legatee and
