Warranty Deed

This Indenture Witnesseth that: John William Halbert and Louise S. Halbert,
husband and wife,

of Orange County, in the State of Indiana, Convey and Warrant to Paul Waynick and
Lucille Waynick, husband and wife

of Orange County, in the State of Indiana, for and in consideration of the sum of one
dollar (\$1.00) and other valuable considerations, the receipt whereof is hereby acknowledged,
the following described Real Estate in Orange County in the State of Indiana, to-wit: A part of
the northeast quarter of section 7, township 1 south, range 1 east as follows:
Beginning at the northeast corner and run west 40 rods, south 103 rods, west 30
rods, south 57 rods to the south line of the northeast quarter aforesaid, thence
east 70 rods, thence north 160 rods to the place of beginning.

Also, a part of the northwest quarter of section 8, township 1 south, range 1
east as follows: Eight acres in the northwest corner of the northwest quarter
of section 8, in the same township and range, located so as to save the spring.
Being the same ten acres willed by Jacob Cook, deceased, to his daughter, Polly
Underwood, except two acres off the north end of said ten-acre tract sold to
Harry Kushener, Jr. and described as follows: Commencing at the northeast cor-
ner of the bridge across Hog's Defeat Creek running east 22 rods, thence north
27 rods, thence west 12 rods, to the branch line, thence southwest 17½ rods to
the place of beginning, containing in all 2 acres, more or less; which lies in
section 8 in township 1 south and range 1 east. *SA*

Subject to roadway conveyed in deed at Deed Record 80 page 541 of the Orange
County Recorder's records.

EXCEPT: A part of the northeast quarter of the northeast quarter of section 7,
township 1 south, range 1 east, and a part of the northwest quarter of the north-
west quarter of section 8, same township and range bounded and described as fol-
lows: Beginning at a silver maple tree at the intersection of the west line of
said section 8, the easterly line of the county road, and the south line of the
Halbert driveway, and said tree being 42 rods, more or less, south of the north-
west corner of said section 8, and also 4.5 rods, more or less, south of Halbert
Spring Branch, thence east 49.5 feet, south-38°-30'-east 155.3 feet, south
47°-34'-east 247.5 feet along the south line of said drive to the Halbert property
line, thence south 246.5 feet parallel to the section line, thence west 371.0
feet to the county road, thence north-26°-west 146.9 feet, north 198 feet, and
north-27°-24'-east 231 feet, all along said road to the point of beginning.
Containing in section 8, 3.046 acres; in section 7, 0.958 acre and containing
in all 4.00 acres, more or less, in said exception.

northeast quarter of section seven (7), township one (1) south, range one

section seven (7), thence west thirty (30) rods, thence south one hundred

three (103) rods to the place of beginning, containing twenty (20) acres,
