This Indenture Witnesseth that: Doris Jean Parks AUDITOR, ORANGE COUNTY

of Orange County, State of Indiana, CONVEY AND WARRANT to Charles Lindley and Jane Lindley, husband and wife

of Orange County, State of Indiana, for and in the consideration of one dollar and other good and valuable considerations, receipt whereof is hereby acknowledged, the following described Real Estate in Orange County, State of Indiana, to wit Lots numbered seven (7), eight (8) and nine (9) in the Whitmire Subdivision of a part of the South Half of the Northeast Quarter of section 34, Township 2 North, Range 1 West of the Second Principal Meridian, Paoli Township, Orange County, Indiana.

Also, a part of the following described real estate which description in total represents the closing of the railroad right-of-way along a number of tracts of land A part of the south half of the northeast quarter of section 34, township 2 north, range 1 west, Paoli Township, Orange County, Indiana, and also being part of Parcel No 7. Beginning on the south right-of-way line of the "Monon" Railroad at the centerline Station 517 + 00 and on the west line of said northeast quarter, 225 feet, more or less, north of the center of said section 34, thence north 64 5 feet along the quarter line to the north (33 foot right-of-way line, thence south-85°-east 1177.1 feet, all on the right-of-way line (deeded 66 feet-33 feet each side) to P T Station 505 + 27, thence 305 feet along a 1 degree curve to the left, with an angular change of 3°-45'-to the P C.
