WARRANTY DEED

WITNESSETH: That the Grantor, for and in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby CONVEY AND WARRANT, to Grantee, the following described real estate located in Orange County, Indiana, to-wit:

A part of northeast quarter of the northeast quarter of Section 29, Township 2 North, Range 2 West as follows: From the northeast corner of the quarter-quarter section, thence south 1,200 feet along the section line, thence west 800 feet to the point of beginning, thence south 300 feet, thence west 200 feet thence, north 300 feet thence east 200 feet to the point of beginning, containing 1.3 acres, more or less.

Said description determined by Daniel L. Understahl and is a portion of that land described in the Warranty Deed dated March 9, 1976, recorded in the Orange County Recorder's Office on the 11<sup>th</sup> day of March, 1976 in Record No. 126, page 634-635, wherein Ned Moore and Golda Moore, husband and wife and Glenn Moore and Mary Jane Moore, husband and wife as Grantors conveyed 119.18 acres, more or less, to Jess R.
